I suggest we add the comments appreciating participation right at the front of the review where we report on responses. Something along the lines of  
"We are greatly appreciative of the levels of engagement and thoughtful responses during this review."

Then at the start of the Macclesfield section, something along the lines of  
"Our draft recommendations for Macclesfield, which received support, were contingent on Springwood to the north being warded with Bollington. *Based on the evidence supplied to us, we have been persuaded to include this area within Macclesfield. As a result, it has been necessary to amend our proposals in other areas of Macclesfield to achieve the best overall balance of our statutory criteria.*"

I'm suggesting we confine our comments here to the split between Bollington and Macclesfield rather than wider Tytherington changes. Does Springwood adequately describe this area south of the Silk Road?

I see Bollinbrook as a second order change and Beech Farm Drive as an internal adjustment.

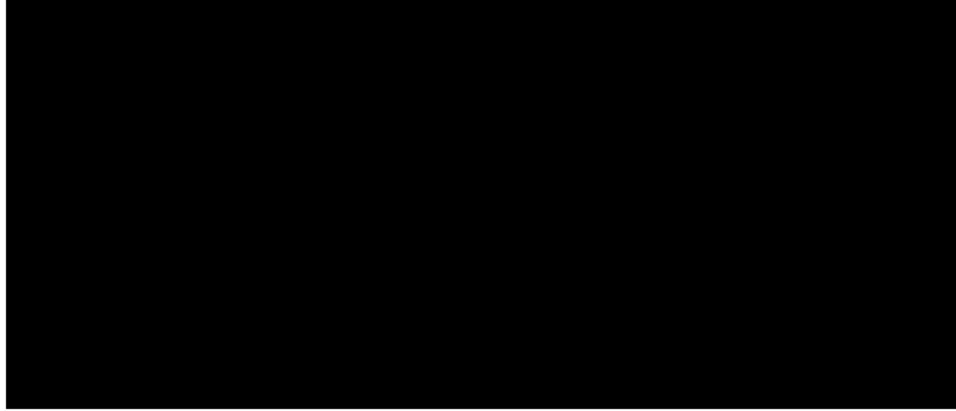

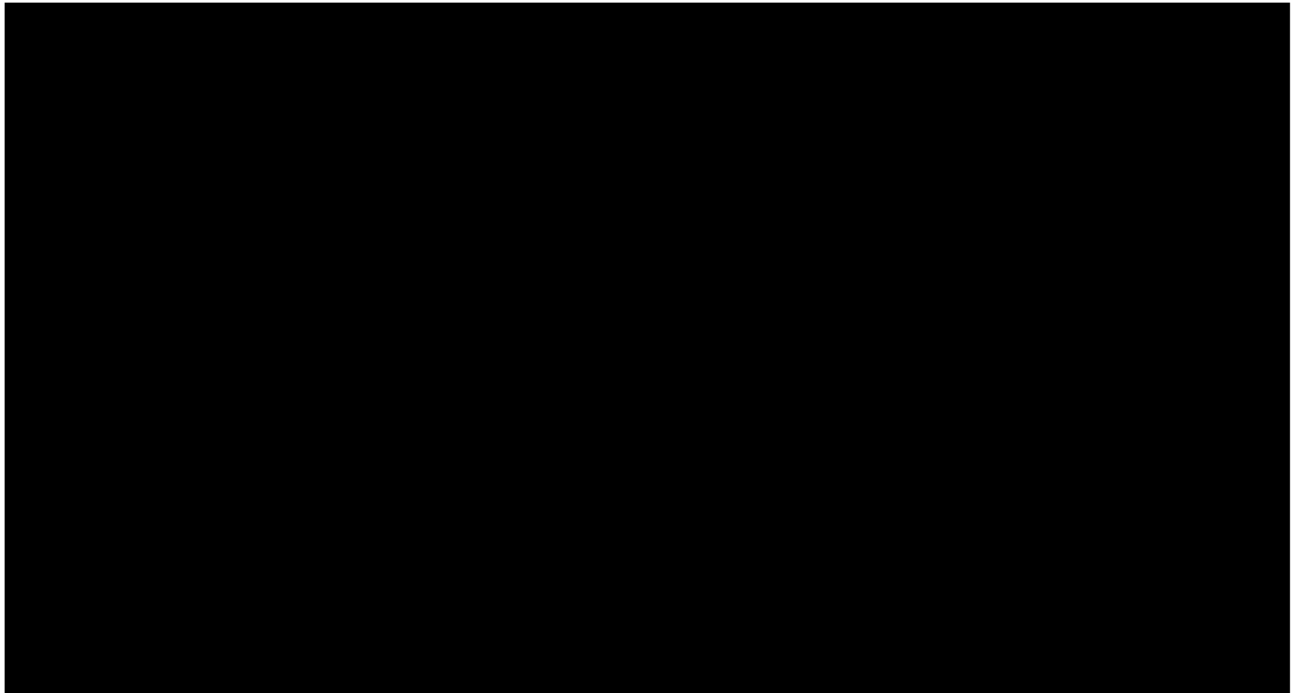
